**Rules:**

- 1) Only two entrants per boat.
- 2) Only live fish will be weighed.
- 3) A maximum of 10 crappie per boat will be weighed.
- 4) BIG CRAPPIE will go to the highest weight of single fish.
- 5) All Missouri State Fishing/Boating regulations shall be followed.
- 6) Any legal methods will be allowed per Missouri Fish and Game Regulations.
- 7) No fishing within 50 yards of another contestant's boat or within 100 yards of boat ramp.
- 8) All contestants are to wear personal flotation devices any time engine is running.
- 9) All boaters must have liability insurance in force on the boat that they will be using.
- 10) If there is a tie for the largest weight, the boat with the largest single fish will win.
- 11) If there is a tie for big crappie, the boat with the earliest entry will win.
- 12) The Tournament Directors reserve the right to change, add or delete prior to the start of the Tournament.
- 13) All decisions by the Directors are final.
- 14) Liability Release: By signing this agreement, I hereby release all tournament officials, sponsors and all persons involved with the operation of this tournament, for any or all damages, claims, costs, or expenses relating to any injury of any persons or property damage which I may sustain or cause by any reason of participation or in connection with this tournament.
